Through a Scholarship Fund at the Community Foundation for the CSRA, individuals, families, businesses and other groups can make the dream of higher education come true for students across our region.

STARTING YOUR FUND IS EASY

Our experienced team will work with you to identify your personal charitable goals and design a scholarship fund that aligns with the educational values important to you. Scholarship Funds provide a powerful way to support a wide variety of educational needs from preschool to postgraduate work and may honor or memorialize a loved one. You can determine the eligibility and selection criteria, award amounts and selection committee. And, if you choose, you may be involved in the recipient selection process.

Scholarship Funds operate as endowed funds; therefore, we prefer a \$10,000 minimum gift to establish a Scholarship Fund. Maintaining a minimum \$10,000 balance ensures a minimum \$500 scholarship award is given each year in perpetuity.

Consider a Scholarship Fund if You:

- Seek simplicity and ease in your giving
- Want to support a specific field of study, educational institution, academic or extracurricular achievement or any variety of educational endeavors important to you
- Want to be involved in your philanthropy by creating eligibility and selection criteria for recipients
- Want to honor or memorialize a loved one
- Wish to create a charitable legacy to support educational needs
- Choose to invest in the future of our community by helping deserving students seize educational opportunities they otherwise may not have had

You determine the scholarship purpose and selection criteria, and we manage the administrative details to ensure awards are disbursed in accordance with the process you identify and all IRS regulations.

Your fund is established based on your values and charitable goals. You create the eligibility criteria and selection guidelines, and your fund will only award scholarships to eligible recipients selected by the committee you designate.
